1. Who can receive free or reduced cemeals?

- x All children in households receiving benefits from SNAP, FDPIR, or TANF, are eligible for free meals.
- x Foster children that are under the legal responsibility of a foster care agency or court are eligible for free meals.
- x Children participating in their school's Head Start or Early Head Start program are eligible for free meals.
- x Children who meet the definition of homeless, runaway, or migrant are eligible for free meals
- x Children attending CEP campuses receive meals at no cost.
- x Children may receive free or reduced-price meals if your household's income is within the limits on the Federal Income Eligibility Guidelines. Your children may qualify for free or reduced-price meals if your household income falls at or below the federal limits.

2. How can I obtain ar Fe & Reduced Price Meal application?

Applications are available for parent or guardian pickup beginning July 1st at the Free & Reduced Office at 7520 Mainland Drive, San Antonio, TX 78250. Hours are 7 AM to 3:30 PM (Monday – Friday). Applications may be turned in at the Free & Reduced Office, left at the courtesy drop box or mailed to this address. Applications will be available at non-CEP campuses beginning in August.


